Bishop Rhoades to Celebrate Annual Mass

Christ Child is honored to have Bishop Kevin Rhoades celebrate its annual Mass on March 26 at the Church of Loretto on Saint Mary's Campus. The Wednesday Mass is at 11:00 AM with lunch immediately following at the Gillespie Center at the Hilton Garden Inn, just north of the college.

Members are asked to bring an item for the Layette Department to the Mass. The onesies, receiving blankets, sleepers and other items will be taken to the altar at the Offertory of the Mass. Every year those attending the Mass have been very generous in helping supply our Layette Department with needed items that go to the new babies born in our local hospitals. The mothers of the infants are so pleased to be able to take their baby home in new clothing provided by The Christ Child Society.

Bishop Rhoades will join us for lunch and the annual meeting. New board members will be introduced and voted on by the general membership attending the luncheon. The agenda will include projects that were accomplished in the past year and what is being planned to move our Chapter ahead in the future. Among the reports will be an explanation of what is in each layette and of the Layettes of Hope. For those of you who do not visit the Center regularly, you will be brought up to date on what programs our Christ Child Center continues to do for our infants and children.

The luncheon reservation is on page four of this newsletter. The Mass parking lot is east of the Church with drop off space and limited parking in front of the Church. Ample parking for the Gillespie Center is north of the HIlton Garden Inn. With the Center closed to clients for the season, this is a great chance to visit with other members and enjoy Mass and lunch with those who share the love of Christ Child.

Members Offered New Fund Raiser

Our members have been offered a new and easy way for our organization to raise funds. Notre Dame Federal Credit Union has set up a plan that any member who qualifies (most of us do by belonging to a Catholic parish) can open a Christ Child VISA Platinum account. This account has no annual fee and

a 1% Cash Back bonus on all of your purchases is donated in November of every year to The Christ Child Society on your behalf.

We have application forms at the Center and will have them available at the March luncheon at Gillespie Center on March 26th. You can also stop in to any Notre Dame Federal Credit Union branch and tell them you want to apply for a Christ Child Society VISA Platinum



for a Christ Child Society VISA Platinum account.

The card itself has The Christ Child Society logo on it plus our Clothe-A-Child II "kids" who are waving hello in their warm clothing supplied by Christ Child. This is an easy way for all of us to donate and not miss any out-of-pocket money. This will replace our gift wrapping fund raiser at the Notre Dame Book Store which has been discontinued by the University.
